#### 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

The Government Sanskrit College was established in Sikkim in the year 1997 at Galyshing (W) Sikkim. Since its inception, it has been affiliated to Sampurnanda Sanskrit University, Varanasi, (U.P).

Later, it was shifted to Samdong, (E) Sikkim in its own registered land. The total area of college is 9.16 acres with a suit up area of 2914 Sq.Mtr. the college is situated in a pristine beauty of Nature facing towards Mt. Khanchendzonga (the Guardain unity of Sikkim). The major subjects taught in this institution are Sanskrit Grammer, Sanskrit Sahitya, Jyotisha, and Purana Itihasha along with Hindi, English and Nepali. This is an exceptional Institution imparting Sanskrit education in the entire North-East covering Darjelling, Kalimpong Bhutan and Nepal as well. The college strictly follows the curriculum framework of Sampurnanda Sanskrit University. The classes are run from madhyama (certificate Level) to Shastri level (UG Level) as per approved curriculum of SSVV, Varanasi (UP). From this academic sessions college has started Post Graduated courses in Sanskrit subject under Sikkim State University.

#### Vision

The college is committed to become a premier institution in the field of Sanskrit education which is one of the most important languages of the Indo- European family. It has a very rich and continuous history of nearly 5000 years. Sanskrit is universally recognized language of the world and also the mother of maximum numbers of North Indian languages. The colleges is determinate to create skill- oriented professionals / Academicians /Research scholars on whom the preservation of this rich language could be entrusted upon.

#### Mission

Government Sanskrit Mahavidyalaya, Samdong (E) Sikkim was the first institution of higher Education of Sanskrit studies in the State of Sikkim.

It was established with a view to cater to the needs of Students who were compelled to go outside the state after completing their School Education in Sanskrit from various schools of Sanskrit across the State.

This Institution is working towards conducting various skill oriented professional courses (karma Kanda, Jyotish, Purana Ithihasha, yoga etc) including academics.

These value added courses shall provide and enhanced lifelong learning opportunities to the young generation so as to make contribute pro-actively to the socio-economic development of their families, communities, State and nation as a whole.

#### 1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

#### **Institutional Strength**

- Before 2 decades students who wanted to pursue Sanskrit subject for higher Education they had go to outside the State. But after opening of this institution they could complete their higher Education in Sanskrit within the State.
- The Government of Sikkim provides free education to all the sikkimies students, and a very few fees for other non-local Students, which gives opportunities to the rural students to pursue their Higher Education in Sanskrit.
- The institution organises different co-curricular activities/ programmes at a regular interval and also organise various carrer related programmes like- study tour, (National International), sport, culture, related activities.
- The teacher student ratio of this institution is very satisfactory and encouraging, by which students gets individual attention from the teachers.
- This Institution is only o Higher Educational institution of Sanskrit studies in the state of Sikkim which is located in a very eco-friendly, pollution free environment in hilly area and with a greater potential to attract foreign (specially European) students in future.
- Large number of class rooms, furniture, efficient numbers of teachers, availabilities of books, and I.C.T related equipments encourage the students for better learning.
- From this academic seassion we have started post graduate course which enable them to have more opportunity of higher education locally.

#### **Institutional Weakness**

- After availabilities of various types of facilities like: class rooms and infrastructure, well qualified teachers, good environment, this institution has to face the lackness of students.
- Being located in a rural and remote area the college faces erratic Electricity supply.
- Because of the location aspects and weak communication network the college has no Internet facilities so far which is major problem for faculties to use the I.C.T enable classrooms and as well for the learners to update and upgrade the information.
- The inefficient number of enrolment in the institution is a major weakness of the institution because of less –scope of Sanskrit education in present era.
- At present the institution could not provide girls hostels, cafeteria, staff quarters etc, which is a hindrance for the development of the institution.
- The college administration could not yet covered its area by boundary wall and installed CCTV monitoring system for the safety and security of the students and college.
- Sanskrit has a lots of area of research but have no facilities for Research due to paucity of adequate funds.

#### **Institutional Opportunity**

- Sanskrit Education is gradually introducing in large number of Universities across the Globe. This institution has a great opportunity to produced and provide Sanskrit scholars for different universities of the world in years to come.
- Sanskrit Education system always talks and advocates to save the nature and always teaches to tune with the natures rhythm, this institution has relevant and efficient environment structure for Sanskrit studies for all interest people around the Globe.
- P.G courses can be introduced in few subjects as most of facultie members are eligible.
- Being the first organic State of the country, and since the college has a large area, different innovative and organic farming can be done involving the Hostellers (students). In order to develop their organic farming skill and to produce Vegetables for themselves.

#### **Institutional Challenge**

- So far there are very less Service sectors in the State and Country who can offers job opportunities for Sanskrit students, so our main challenge is to guide the students for getting job in other sector too.
- Some how to make pressure to the affiliating university to draft/ review the syllabus of all the courses in order to help our students for getting job.
- This institution is affiliated to Sampurnananda Sanskrit University, Varanasi (UP). This university is still having traditional approach in its educational system. College do not have the right to set the questions, revise syllabus etc. College just to follow the guidelines of university which have annual system of exam.
- Being a Higher Educational Institute of Sanskrit Studies we have to work towards translation of various Sanskrit Scriptures, and this college is planning to do so in days to come.

#### 1.3 CRITERIA WISE SUMMARY

#### **Curricular Aspects**

The college has implemented the curriculum formulated by the affiliating University. This college's affiliating University which used to provide the Sanskrit Education in the way of ancient Indian traditional education system (Gurukul parampara). But from two decades (after 2000 AD) the university brought some changes and started to follow certain modern teaching method. Affiliating University (SSVV) has more than 100 affiliated colleges across the country but the course curriculum of these colleges including Government Sanskrit College, Samdong are concern, the University it self makes syllabus and review of syllabus time to time with its own Internal members of syllabus committee. It never asks for advice from this college for making and updating its curriculum and syllabus of any programmes. And we compelled to enforce action plan for implementation of the curriculum as per the guidelines laid down by the University. We try to ensure minimum 180 teaching days. During University examination / centralized evaluation, we reschedule routine, so that classes may not suffer. We also conducted pre-university exams for better performance of the students.

Further, quarterly internal Examination is conducted by the college to assess their continuous achievements and their grasping capacity.

In the beginning of the day of college, students are assemble in the academic building so that they could pray

to God for well time ahead. In this time all the students are provided information about various topic by college faculties.

#### **Teaching-learning and Evaluation**

- The admission of the college is centrally managed by college Administration itself.
- This college runs with insufficient numbers of students as comparison to its infrastructures, faculties and availability of facilities.
- There is no any admission fees are taken from local students and very normal fees is collected from other students during the admission.
- Reservation of seats for different categories is strictly maintained according to the Government rules. But due to the lackness of students number we never need to look for reservation rules regarding admission, it will be strictly follow when needed.
- Government Sanskrit College, Samdong has a strong student support system where various cells are created to provide academic and non -academic activities.
- There is no any credit system or semester system in course runs by Government Sanskrit College, Samdong. Affiliating University totally looks after final examination and evaluation of answer papers.
- College organizes remedial classes for the students(if needed), and at the end of the session or before examination.
- All the faculties Listen the students problems and give them proper guidance and counseling.

#### Research, Innovations and Extension

- The faculties encourage and motivate the students for research and analysis in the UG level by organizing various programs, study tour within and outside India.
- The college has installed a Board to paste wall article on various topics, Research papers etc (BHITTE PATRIKA PATAL) and all faculties and students are being encouraged to write on various topics.
- About 3 faculties have been awarded Ph.D, 6 faculties have been awarded NET and 1 faculty have been awarded SLET, 2 faculties are to pursing Ph.D provision of leave are made by the management as per the guideline of Director of Higher Education, Government of Sikkim.
- Academic leaves are granted to the faculty members to attend National, International Seminar, Conference etc. Government Sanskrit College, Samdong has recently organized a National Seminar on "Unpublished Manuscripts", Vedic Sammalanam, International workshops and Yoga camp etc.
- The college also invites resource persons from different academic institution, Universities and various organizations of our nation and outside the nation to address our students.

#### **Infrastructure and Learning Resources**

- The institution believes that that effective infrastructure and learning resources enhance the quality of the activity of teaching and learning.
- To increase new infrastructure and improve and maintain all the old infrastructure, college utilizes the funds provided by the state Government and other funding agencies such as RUSA,R.S.Sansthan etc.
- The college has a football ground, one volleyball court, one Badminton Court, and other infrastructures

of the college are under construction such as Ground fencing, basket ball court etc.

- There are 17 classrooms including two smart classrooms in the institution.
- The college has a students NSS wing which is engaged in organizing most of the extension activities of the college such as social awareness camps, Swatcha Bharat Mission etc.
- The college has filtered drinking water facilities for everyone.
- The college has a Library with number of books of various subjects, recently which was upgraded with various new books of Rs. 3, 50,000 and where students and other learner can learn the Books of their intrest.
- In this institution there is a parking space available for all concern.
- The rooms (offices) has provided to all the cells of college such as IQAC, SRC, SC/ST Cell etc.
- The college has its own sound system and smart class room.
- The Hostel facility is also available for boys students and the Budget for construction of girls Hostel is also about to allocate.

#### **Student Support and Progression**

- Government Sanskrit College, Samdong believes that students are main part of this institution and are the most important component of its functioning. Since the institution located in a rural area, a majority of our students come from the families of average and constrained socio-economic background.
- Students are provided counselling, guidance, and support by all the faculties by delivering speeches and information about new subjects and carrier related topics.
- The Sexual harassment cell has been constituted to provide students a safe, healthy and congenial atmosphere within the campus and outside.
- Several numbers of faculties write and publish wall magazines to encourage literally skills among students. The college has published its first Annual magazine "SIKKIM PRAVAH".
- The institution encourages and supports those students who have the skill of sports/ writing/ Debate etc so that they could furnish their co-curriculum activities and could get status in State/ University / National Level.
- In order to promote unity and brotherhood among the students the college has an elected students body, which fosters the basic objective of maintaining the welfare of the students.
- The college provided Library facilities for all the students.
- There is a special class room build for physically challenged students.
- College has subscribe regular local news paper to update the knowledge.

#### Governance, Leadership and Management

- The Governance, Leadership and Management of the institution are based on the principle of purely democratic and transparent approach. The college has a well matured administrative structure.
- All the recruitments, transfer, Carrer advancements, promotions both for teaching and non teaching staff and fund allocation is directly done by the Directorate of Higher Education, Government of Sikkim. All fund allocation and management of college's properties is done by the Principal, CMC, IQAC cell, collectively with the supports of teaching and non-teaching staff of the institution.
- The college management committee, parents, well wishers, and alumni of the institution have always joined hands with the college to its growth.
- All the teaching and non-teaching staff of the college used to send to different parts of the country for various different training program to upgrade their skills.

#### **Institutional Values and Best Practices**

- The college has been practicing innovative and creative practices like gardening, plantation and cleanliness drive, Health camp, Mental Health camp, Blood donation camp, HIV awareness camp etc under NSS unit of the college.

The College Teachers are not invited so far in syllabus review/ framing session made by the University. Our affiliating University focuses on traditional teaching techniques and values along with adopting some modern teaching teachniques for which university reviews its syllabus by focusing on these matters. In the beginning of the new session all the teachers discusses on smart implementation of syllabus and they designed teaching planes and time table for timely completion of syllabus within the academic calender issued by the college itself. Allotment of classes as per the routine and requirement is prepared and the requirement of study materilas and reading materials is also intimated to the head of the institution. Teachers try to teach with effective manner .Sometime teachers called the students and to reach the class .Advance syllabus for next class in given to the students so that they came with preparation.
